A RESOLUTION OF THE NORTH MANHEIM TOWNSHIP AUTHORITY  
AMENDING PRIOR RESOLUTIONS AND HEREBY  
ADOPTING RULES AND REGULATIONS AND SPECIFICATIONS  
FOR THE INSTALLATION OF SANITARY SEWER FACILITIES  
CONNECTED TO THE SANITARY SEWER SYSTEM OF THE BOROUGH OF  
ORWIGSBURG

WHEREAS, the North Manheim Township Authority (hereinafter "Authority") provides public sanitary sewer service within North Manheim Township; and

WHEREAS, the Authority previously adopted Rules and Regulations on April 23, 1991; and

WHEREAS, the Authority amended its prior resolution and adopted of even date herewith the Rules and Regulations and Specifications for the installation of Sanitary Sewer facilities, consisting of Book 1 and Book 2, dated March 2012, as prepared by Systems Design Engineering, Inc. ("Specifications") as may be amended from time to time; and

WHEREAS, portions of the Authority sanitary sewer system are connected to and served by the sanitary sewer system of the Borough of Orwigsburg.

NOW, THEREFORE, BE IT RESOLVED by Authority as follows:

1. The Authority amends its prior Resolutions and adopts the Standard Specifications for Water and Sewer Line Construction for the Borough of Orwigsburg dated June 2003 ("Orwigsburg Specifications") specifically and solely with respect to the installation and operation of sanitary sewer facilities located in North Manheim Township which facilities connect to the sanitary sewer system of the Borough of Orwigsburg. The Authority does not provide water service.

2. To the extent the Specifications conflict with the Orwigsburg Specifications with respect to the installation and operation of sanitary sewer facilities located in North Manheim Township which facilities connect to the sanitary sewer system of the Borough of Orwigsburg, the Orwigsburg Specifications shall control.

3. In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Resolution, it being the intent of this Authority that such remainder shall be and shall remain in full force and effect.


4. All resolutions or parts of resolutions of this Authority which may be inconsistent with this Resolution shall be and the same expressly are repealed.


5. This resolution shall become effective immediately.
